1. The Organization has received the following:

3. The Organization is fully responsible for all passes issued. If any of the passes are unaccounted for or damaged, the Organization shall pay Easy Clean Car Wash, Inc. as if the passes were sold. The Organization understands that passes may be returned in book form only and that individual passes are not returnable.

4. The Organization has 7 days from the last sale date to settle their account with Easy Clean Car Wash, Inc. The organization is required to pay 50% of all the coupons issued. We accept cash, check or credit card. The Organization will not be charged for any passes returned in book form that are reusable by Easy Clean Car Wash, Inc. All passes returned in book form must be returned in "perfect" condition in order to be accepted by Easy Clean Car Wash Inc.

5. The organization will provide a credit card (not debit card) as collateral and/or method of penalty payment. In the event that the Organization does not comply with #4 paragraph of this contract, then the credit card will be charged for the amount due to Easy Clean Car Wash, Inc. If any collection problems occur, the Organization will be held responsible for all fees (legal and other) that may be incurred by Easy Clean Car Wash, Inc. in order to enforce the terms of this agreement.

6. During the selling process, your organization is not considered employed by Easy Clean Car Wash, Inc. Easy Clean Car Wash, Inc. is not liable for any injuries or damages that might occur during the selling of Easy Clean Car Wash, Inc. passes for your organization.
